

# St. Mark Preschool Scholarship Program

It is the intent of St. Mark Preschool to provide financial assistance to children based on family eligibility. Financial assistance is granted in the form of **partial tuition scholarships**, contingent upon the availability of funds. Determination of eligibility and the amount of the scholarship granted is by decision of the Scholarship Committee of St. Mark Preschool.

The following guidelines are used for this determination:

1. Scholarship fees will be limited as to availability of funds and limited to a total of two years per child.
2. Your household must meet the Government Guidelines for Income Eligibility requirements for Free and Reduced Lunches **and/or** have special circumstances that will affect your ability to pay full tuition.
3. Eligibility for special circumstances is determined on a case-by-case basis, taking such factors into consideration as job loss, illness, death, or other situation(s) that affect the family's ability to pay.
4. Qualified applications will be kept on file for one year.
5. Scholarships will be granted on a first come first serve basis.
6. **Completed applications must be returned to the church office by July 15, 2018**, attention Allison Wentz.

Government Guidelines for Income Eligibility Requirements: Participants from households with incomes at or below the following levels may be eligible.
